### CONTEXT

International trade in food, products of animal origin and live animals is governed by international sanitary agreements that guarantee food safety and animal health. These agreements imply the respect of international sanitary standards that states must comply with in order to participate in trade.

### PROGRAMME

#### Main objective:

At the end of this module, participants will know the foundations of the development of international sanitary standards, the impact for veterinary public health of non-compliance with these standards and the missions of certifying veterinarian.

#### Learning objectives:

At the end of this module, participants will be able to:

- Explain the foundations of SPS agreements and know how to follow the evolution of international health standards;
- Negotiate the sanitary conditions of import and export;
- Design health certificates (export), control health certificates (import);
- Explain to the competent authorities and employees the differences in conformity with respect to the expected standards and to propose actions to comply and secure trade.

Critical PVS skills that should be strengthened during this module are:

- o Section II-4 Quarantine and border security
- o Section IV-3 International Harmonization
- o Section IV-4 International Certification
- o Section IV-5 Equivalence agreements and other types of sanitary agreements
- o Section IV-6 Transparency

#### Course Content:

1. Certification for trade: general rules
  - Part 1. 1. Definition of international sanitary standards for trade
  - Part 1. 2. Design of a health certificate
2. Export certificates: the responsibilities of the certifying veterinarian
  - Part 2. 1. Missions and functions of certifying veterinarians.
  - Part 2. 2. Examples of certificates: are they compliant?
3. Import certificates: are border controls or import regulations effective?
  - Part 3. 1. Border inspection post: missions and infrastructure
  - Part 3. 2. Internal organization of a border inspection post and control procedure.
