# **CONTEXT**

One health is a culture change that concerns us all. With the Covid crisis, we realize that an animal disease can become a threat to public health, with consequences for the economy, the environment and societies. From now on, human health, animal health, plant health and preservation of ecosystems are one.

Understanding the interactions between different environments requires interdisciplinary thinking. We already know that 75% of emerging diseases are associated with animals and the collapse of biodiversity such as climate change or chemical products are impacting our health. The new comprehensive OHHLEP One Health definition (*One Health High-Level Expert Panel*) aims to promote a clear understanding and translation across sectors and areas of expertise.

We must increase knowledge of One health in curricula but also within civil society and public and political decision-makers. In March 2023, ENSV-FVI launched the new One Health French institute that will provide expertise and training for both public and private sector professionals.

#### **PROGRAMME**

# Main objective:

At the end of this training, participants will have acquired knowledge and skills in operational One Health implementation. This residential course aims to mainstream and operationalize One Health at global, national, and local levels.

### Learning objectives:

- Know the main concepts and stakeholders of One Health implementation with concrete examples
- Acquire key One Health skills
- Understand drivers and strategy of institutions officials at local, national and international levels in matters of One Health.

# **Course Content:**

- The different examples of One Health activities.
- Appropriate management and leadership to implement One Health activities.
- One Health network animation and One Health project management.
- Case studies on One Health activities at local, national and international levels.
- Feedback and interactions with various One Health leaders at local, regional and international level. Synthesis of the main lessons learnt.

# Teaching methods:

Presentations, practical training based on case studies, working groups, sharing of experiences, field visits, European study trip.

#### **Prerequisites**

Minimum of 3 to 5 years of relevant professional work experience. Reasonable proficiency in English.
