CONTEXT

The European Single Market has shifted sanitary borders to the limits of the European Union and established mandatory control points at the entrance to the territory for animal and plant products. As a result, imported consignments must be presented at border control posts (BCPs) located near the borders in areas of high traffic concentration: maritime ports, international airports, and major highways.

The training will focus on veterinary controls at importation, specifically the importation of live animals, animal products, and non-animal origin feed for animals.

PROGRAMME

Main objective:

To understand and strengthen the harmonized procedures and methods used during veterinary controls at importation.

Learning objectives:

- Identify the rules governing the importation of the relevant consignments
- Understand the roles of BCP officers
- Identify the role of customs and the applicable customs procedures

• Examine regulatory changes and analyze the evolution of regulations along with the role of the European Commission.

Course Content:

- Institutional environment of border control posts
- Legal foundations of veterinary controls at importation
- General and specific modalities of the control
- Information systems and control registration systems
- Customs procedures economic customs regimes

Teaching methods:

Lectures, practical training based on case studies, groups work, experience sharing, field visits and a study trip.
